## 1. EXECUTIVE SUMMARY

#### 1.1 INTRODUCTION

Government M.M.R. PG. College, Champa is situated in Bilaspur Howrah Rail Section of S.E.C. Railway, 10 Kms far from the district head quarter. The flow of Hasdeo river and natural surrounding make its location very attractive.

Our College is being governed by the rules and regulation laid down by the department of Higher Education, Govt. of Chhattisgarh, Raipur and was affiliated to Bilaspur University, Bilaspur. At present in the year 2021-22 the college is affiliated to Shaheed Nand Kumar Patel University, Raigarh. The college was established as a Govt. College in the year 1974 with only Arts faculty. Later graduation in Commerce and Science faculties was started in the year 1981 and 1982 respectively. Post Graduate classes for M.A. in Political Science and Economics were started here in the year 1983-84. M.Com. was started in the year 1985-86 and M.A. in History was started in the year 2006. M.A. English Literature, M.S.W, P.G.D.C.A., M.Sc. Mathematics and Chemistry, and B.Sc.(Computer Science) were commenced under self financing scheme in the year 2001. 'Tasar' was added as elective subject in B.Sc, Biology group in the year 2001. Many sports loving students of the college have achieved medals and certificates in the district, division, state and national level sports competitions. NSS Unit is running successfully here with 100 members. Seven days NSS camp is organized every year in the nearby villages. More and more attempts are being done by the College and NSS Unit for the complete personality development of the students.

The college library is working in satisfactory manner with Wi-Fi connectivity and computer facility. It is also providing facility of e-books and e-journals to the students through N-List subscription. Some necessary books are purchased every year to meet the need of present day's challenges. The whole college campus is developed as Wi-Fi zone and college students can access internet facility all over in the campus. Smart Classrooms have taken the teaching learning to a well equipped techno- savvy environment.

To assure good administration some rules and regulation are framed by the College administration and all the students have to follow them. In this way, the college is doing its best efforts to spread education in this region in the best possible way.

- Students' satisfaction survey which is conducted in all the sessions since 2015-16 is a direct source of measuring the satisfaction level of students.

- The college has applied for research center in Commerce stream, as Head, Department of Commerce is a registered research guide in two different Universities.

- There are 28 class rooms, 05 laboratories with proper seating lighting and green board. 04 rooms are equipped with ICT facilities. The college has a girl's common room, separate washrooms for boys, girls and disabled students. One Computer Lab is there with all necessary accessories.
- The college has 04 internets access center.
- Free internet facility for students and teachers is provided in the college.
- Separate library building of the college is one of our specific achievement. Library is semi automated with having good numbers of books, magazines and News Papers.
- Inflibnet subscription is one of the remarkable achievements of the Library. This registration is done in the year 2020-21.
- Study room facility is also available for the students' information and to enhance their competitive knowledge.
- The college has 06 well-equipped Laboratories in the Departments of Physics, Chemistry, Zoology, Botany and Tasar.
- The college has a girls' hostel with a capacity of fifty girls within the campus which is not functional yet because the boundary wall is not yet built.
- The college has indoor and outdoor sports facility for Volley-Ball, Table Tennis, Chess, Kho-Kho, Kabbaddi etc with a gymnasium. Some outdoor games like Cricket, Basket Ball are organized off campus.
- The College has separate generator and transformer for power backup whenever it is necessary.

- Various Cells and Committees like Grievance Redressal Cell, Anti Ragging Committee, Disciplinary Committee, Placement Cell, Mentor-Mentee scheme, Career and Counseling Cell and Students' Union function in the college to provide support to the students for their overall well being.

- At the very outset of every session, an Induction Program is organized to get the newly admitted students acquainted with all the aspects of college. General information about the college is also available on the website.

- The college also fulfills its responsibilities towards the society through NSS and Red-cross unit by organizing various activities for awareness of health. Health camps are organized for blood group test, blood donation, health check-up, removal of mental stress during examinations etc.
- NSS and Red-cross wings engage the students in the community development activities which motivate them to involve in social services.
- Various activities are held regularly under the banner of SVEEP.
- There are Grievance Redressal and Sexual Harassment Cell to resolve the problems of students. Many enrichment programs are regularly organized on women's issues to install moral and ethical values under the in the students.

#### 1.1 Curricular Planning and Implementation

# 1.1.1 The Institution ensures effective curriculum delivery through a well planned and documented process

#### **Response:**

Government M.M.R.PG College Champa is affiliated to the Atal Bihari Vajpayee University, Bilaspur and follows the curriculum developed by the university. It deploys a number of action plans for its effective implementation at various levels. After the communication received from university in the beginning of the session, principal communicates the syllabus and other guidelines to the respective departments and through them students are informed. Department wise induction is a part of our culture. These induction programs are healthy practice to welcome the students and introduce them to the college culture. Marks scheme, syllabus, attendance monitoring are introduced in an amicable atmosphere. Students get the opportunity of interaction with the Librarian, Sports Officers, Coordinator, training and placement cell and coordinators of various cells of the institution. College introduces the students about, self-financing courses and short-term diploma courses. Time table committee prepares the time table for all the departments taking into view the infrastructure and laboratory needs. College communicates the approved time table to the students. Apart from this, departmental time table is also prepared. College introduces the academic calendar and instructs students to be punctual, as college follows the academic calendars strictly. Admission in-charges are made mentor teachers of the respective classes. They identify slow learners and fast learners and monitor the students accordingly. Various departments organize guest lecturers for the students. Students are continuously informed about the semester process and examination system through career guidance programs. The implementation of the teaching plan and lectures are supervised regularly by the head of the departments and Principal. Every month Professors report about the syllabus completed and gets their daily diary signed by the Head of the Institution.

#### 1.1.2 The institution adheres to the academic calendar including for the conduct of CIE

#### **Response:**

The decision of internal examinations has been taken by the University to make a practice of the students for continuous evaluation. A common academic calendar has been issued by the higher education department to ensure the system for internal evaluation and is implemented across government-run colleges offering Arts, Commerce, Science, Law and Education courses, affiliated with different universities. According to the internal exam schedule of the affiliating University, the college schedules internal examination. Annual internal examination committee is formed for proper functioning of the above mentioned process. Students are informed about the internal examination process at the beginning of

the session through induction program. In a true sense, continuous evaluation process of the students is made by conducting home assignments, tutorials, surprise tests, unit tests, sessional exams and finally annual University exams. As college is affiliated to Atal Bihari Vajpayee University, Bilaspur, it follows the academic system of the same University. Twenty percent of the total marks are allotted for internal exams. College conducts two such exams in a session/semester and takes average of two for the final markings. For PG classes University has started semester system in the session 2016-17 and it is mandatory for all the affiliated colleges to follow this system. Internal examination system is implemented in PG courses also and hence college deploys a separate strategy for PG courses according to semester durations.

This academic calendar is a guideline for systematic chronological academic activities. It covers date of admissions beginning of regular classes, revaluation results, supplementary exams, student's union election and other co-curricular and extracurricular activities. Activities of NSS etc are conducted before Dusshera-Diwali and winter vacations.

- College does not run any course on professional ethics but it grabs all the opportunities to organize programs for such awareness. Commerce graduates and postgraduate students learn such ethics through their prescribed syllabus. Professional ethics are inculcated with the subjects like Insurance, Fundamentals of Entrepreneurship, Accountancy, Mercantile Law, Business Environment and Business Communication, Organizational Behavior, Advertising and Sales Management etc. However, for other students various programs are organized by the Training and Placement Cell to provide knowledge of professional ethics.

#### 2.5 Evaluation Process and Reforms

#### 2.5.1 Mechanism of internal assessment is transparent and robust in terms of frequency and mode

#### **Response:**

Department of Higher Education publishes academic calendar which contains the number of teaching days, internal evaluation and examination dates etc. Govt. M.M.R.PG. College Champa is affiliated to Bilaspur University, (presently affiliated to Saheed Nandkumar Patel Vishwavidyalya Raigrah) and follows the academic calendar issued by the Department of Higher Education, Government of Chhattisgarh. From the month of August unit tests starts in all the departments and college follows the calendar for internal exams throughout the year. Unit tests held every month followed by quarterly, half yearly and pre-final examination. There is an internal assessment cell to coordinate the tests and exams. Timetables are prepared for these examinations and accordingly invigilators are appointed. Internal examination is conducted in two shifts, the first shift usually starts from 11:20 to 12:00 and the second shift is from 12:30 to 01:30. In this way the optimum use of time and infrastructure is designed by the internal exam committee. Proper seating arrangement and display of results make the process transparent. Internal exams for P.G. courses are conducted according to the departmental time-table. Head of the departments of P.G. courses coordinate the process of internal assessment of the students. This internal assessment is comprised

of internal exams, assignments, presentations and over all performances of the students. Online internal exams were conducted for the even semesters of P.G. classes during lockdown period of the session 2019-20.

# **Criterion 4 - Infrastructure and Learning Resources**

### 4.1 Physical Facilities

4.1.1 The Institution has adequate infrastructure and physical facilities for teaching- learning. viz., classrooms, laboratories, computing equipment etc.

#### **Response:**

Augmentation of infrastructural facilities has been a regular practice for sustaining and promoting academic excellence. Keeping in view the role and impact of technological advancements in higher education, the administration has upgraded technology to give a new direction to teaching learning experience at Govt. M.M.R.PG College, Champa. College was established in the year 1974 with Art faculty and today the college has UG and PG programs in Arts, Science and Commerce faculties. In the year 2020-21 total strength of the college is 2474 which was only 75 at its commencement year. Looking to the increasing numbers of students, college administration has tried to enrich its infrastructure physical facilities during the last five years.

**Laboratory:** College has six Labs (physics, chemistry, zoology, botany, computer, tasar). All the Labs have their own timetable for the students. Looking to the increasing number of students college administration is planning to provide two under construction rooms for Physics and Botany Labs.

**Library:** Library in the college has its own building in the campus of the college. It consists of one reading room, main library, Librarian's cabin, washroom and porch. Students can use reading room any time during the library hours.

**Classrooms:** Twenty eight classrooms are allotted for various classes in the time table. Time table is planned to utilize the rooms for multiple subject lectures. Furniture is set according to the capacity of classrooms. These classrooms are also used for various competitions and events organized by science club, women cell and departmental activities.

**Computer Lab:** College has a computer lab with thirty five computers. Two faculties and a lab attendant are deputed through Janbhagidari appointment. In the year 2015-16 one new Computer lab is established by the extension and partition of old library. Built with a new set up.

#### Newly augmented/under process infrastructure during last five years:

- One building with eight classrooms was handed over to the college in the year 2017. This building was funded through RUSA.
- Another building with six classrooms was constructed utilizing state govt. fund in the year 2017.
- Three classrooms of this newly constructed building are augmented as **SMART CLASSROOMS** in the year 2018.
- Renovation work of the old building is under process through RUSA funding.
- New Indoor Badminton Hall is under construction which is sanctioned by UGC and State Government.
- A proposal has been communicated to the state govt. to sanction an amount for the construction of Boundary wall of already existing Girls Hostel Building.
- Note: In the session 2019-20 college building has been taken over by the district collector and has

been provided to the health department as covid-19 wellness center. Since April 2019 till date it is under the possession of district administration. in the month of August 2021, the college has occupied Library block again and started library functioning.

#### **Sports:**

The College has played an active role in the proper grooming of students. Specific spaces have been earmarked for extracurricular activities and made available to students. The playground inside the campus is total 400 meters. Sports department of the college maintains a gym and a playground in the college. A well developed volley ball court, Jumping pit, Exercise bar- double bar and ring bar is available for the students. One indoor badminton hall is under construction. The department has 72 books related to sports activities. Department keeps a record of issuing sports material to the students for sports activities. An issue register is maintained by the department. Loss or intentional damage causes fine to the students. In case of participation of inter-college, state-level and national-level events college provides T.A and D.A to the students according to the government norms. One hall is allotted for gymnasium in the college.

Every year university prepares sports calendar and following the calendar district level and zonal competitions are organized in Govt. M.M.R.PG. College Champa. Students take part in the Inter-college, university, state and regional level sports events regularly. It is noteworthy to mention that our college holds a good number of representations in the University team. Special attention is given to the students who represent the college at the state and regional level by providing them leave and they are also given relaxation to complete their assignments. Every year Annual Sports event is organized where students and teachers take part enthusiastically.

It is user-friendly software developed to work under client-server environment. The software is compliant to international standards for bibliographic formats, networking and circulation protocols. After a comprehensive study, discussions and deliberations with the senior professionals of the country, the software was designed to automate all housekeeping operations in library. The software is suitable not only for the academic libraries, but also for all types and sizes of libraries. The first version of software i.e. SOUL 1.0 was released during CALIBER 2000.

The database of the SOUL 1.0 was designed on MS-SQL and was compatible with MS SQL Server 7.0 or higher. The latest version of MS-SQL and My SQL (or any other popular RDBMS). SOUL 2.0 is compliant to international standards such as MARC 21bibliographic format, Unicode-based Universal Character Sets for multilingual bibliographic records and NCIP 2.0/ SIP2 based protocols for electronic surveillance and control.

The college has purchased licensed software of SOUL 2.0 in the session 2011 and started upgrading the Library according to software. At present the Library is partially automated using this software.

# 4.4.2 There are established systems and procedures for maintaining and utilizing physical, academic and support facilities - laboratory, library, sports complex, computers, classrooms etc.

#### **Response:**

Regarding the maintenance of Infrastructure, higher education department and state government do not provide regular and sufficient fund, so such maintenance are incurred through Janbhagidari fund and other available funds. Regular expenses like electricity and water supply funds are provided by the state government in the annual budget of the college. In the year 2019-20 the college received an amount of 69.49 Lacs for the infrastructure renovation of the old block. According to the Government norms, such fund goes to the Public Works Department and they undertake the charge of construction and renovation. Regarding the regular cleaning, sweeping and maintenance of water stations the college has class four employees who are assigned for cleaning of different sections of the college.

**Laboratory:** College has six Labs (physics, chemistry, zoology, botany, computer, tasar). All the Labs have their own timetable for the students. This is generally mentioned in the main time table of the college. Labs divide their batches and students attend the Labs according to the allotted time of their batches. Lab technician and attendants take care of their attendance and issue them required materials for practical. There are few maintenance rules for the laboratories that, in case of any damage caused by the students, they have to pay fine for the damage in the Lab. All these things are supervised and monitored by the head of the respective departments.

**Library:** Library in the college has its own building in the campus of the college. It consists of one reading room, main library, Librarian's cabin, Washroom and Porch. Students can use reading room any time during the library hours. Library is connected with Wi-Fi and students can browse using the computers of library or through their own devices. For issuing books and reference books library issues a time table and accordingly issue register is maintained. Loss or damage of any type of property of library will bring fine for the students. Library upgrades its infrastructure and other facilities for the students utilizing the reading room fund. Librarian of the college has been utilizing this fund in the most purposeful manner.

**Sports:** Sports department of the college maintains a gym and playground in the college. Department issues sports material to the students for sports activities. An issue register is maintained by the department. Loss or intentional damage causes fine to the students. In case of participation of inter college, state level and national level events college provides T.A and D.A to the students according to the government norms. One hall is allotted for gymnasium in the college. Provision for the maintenance fund of sports department is incurred from the fee of the students.

**Classrooms**: Twenty five classrooms and three smart class rooms are allotted for various classes in the time table. Time table is such planned as to utilize the rooms for multiple subject lectures. Furniture is set according to the capacity of classrooms. These classrooms are also used for various competitions and events organized by science club, women cell and departmental activities. Apart from this, college has a committee for Green campus clean campus which takes care of cleanliness of the campus. Water coolers are cleaned and serviced regularly. Outsourcing is done for regular maintenance of wooden furniture and electricity.

**Computers**: College has a computer lab with thirty five computers. Two faculties and a lab attendant are deputed through Janbhagidari appointment. In the session 2019-20 three smart classrooms were set up for

### 5.3.2 Institution facilitates students' representation and engagement in various administrative, cocurricular and extracurricular activities following duly established processes and norms (student council, students representation on various bodies)

#### **Response:**

Govt. M.M.R. PG. College, Champa runs under the guidelines and ordinances issued by state government department of Higher Education Raipur C.G. and affiliating University, Bilaspur. Students' council election and other activities are planned according to the calendar issued by the State Government. College appoints one union in-charge to look after all the activities of calendar following the rules issued by the University. Candidates file their nominations on the decided date and if more than two candidates file the nomination, that seat will go through election process. Finally, four officer bearers and class representatives form the students union. This union has thirty percent seats reserved for female candidates and one seat among the four main officer bearers is also reserved for female candidates. Students Union plays an important role in all the major activities like - annual function, sports and over all development of the college. Apart from class representatives and four officer bearers, five committees are also formed according to the circular of University for student's representation. All these five committees are under professor in-charge of that particular committee. Women awareness, sports, social work, cultural and science club are such five committees. These elections are subject to the circulars issued by state government and university as well. Sometimes elections are replaced by the merit nominations of the students.

**Science Club**: The aim of the formation of science club in Govt.M.M.R.PG College, Champa, is to encourage the students to participate in various technical activities which provides them a platform to share, enrich and involve in the new technologies. Besides regular meetings and evaluation of the working of the club, this club organizes several programs to make the students aware about the latest trends among youths and for that the club organizes several competitions and provides certificates to the students.

Women Awareness Committee: To bring awareness among female students of the college a Woman Awareness Committee is formed. This committee is specially designed to empower girl child to overcome recent challenges. Female students from all the faculties' i.e, Arts, Commerce and Science are invited as members of the committee. These students are advised to attend meeting whenever it is held in the college. Important suggestions from students are welcomed and are discussed with Principal and other staff members of the college. Apart from bringing awareness among female students, this cell actively takes part in organizing various cultural events and competitions every year in the college.

**Cultural Committee:** Cultural committee of the students looks after all the cultural activities organized for the students in the college. Annual function is one of the major events organized by this committee.

**Sports Committee**: This committee takes charge of all the sports events of the college. Students of the committee act as volunteers whenever college hosts any sector or university level event.

**Social Work Committee:** Volunteers of NSS and Red Cross are made members of this committee. Social work and extension activities come under their focus area.

# 6.1.2 The effective leadership is visible in various institutional practices such as decentralization and participative management

### **Response:**

**Internal Quality Assurance Cell:** Internal Quality Assurance Cell of the college is perfect example of decentralization and participative management. This committee, through its regular meetings ensures the best implementation of above mentioned system. IQAC took charge of enhancement of quality teaching learning, infrastructure, information technology, faculty development and many more such activities of the college. Various functions and initiatives adopted by IQAC are activated after decentralizing the responsibilities to the faculties and staff. IQAC itself is comprised of members from various fields and stakeholders.

**Examination Process** - Examination process is an example of decentralized and participative management. University calls the name of professors and Asst. Professors with Principals recommendations. All the colleges send their list to the University and University announces the names of Superintendent and Asst. Superintendents. All the three shifts have at least three Class III staffs and two Class IV staffs. Senior Superintendent takes care of all the three shifts and the team finally reports to the senior superintendent.

**Annual Sports and Cultural Events:** Govt. M.M.R.PG. College organizes annual function every year. Head of the institution calls a meeting and assigns responsibilities to the faculties and staff. A notice is issued and accordingly the program is organized. These programs are preceded by annual sports of the college in which faculties, staff and students participate as organizer and in this way the activities are coordinated.

**Janbhagidari Samiti:** Following the orders of State Government and Higher Education Department, College has a Janbhagidari Samiti to ensure the local participation. Formation of this samiti follows the directions issued by the State Government. This samiti is comprised of exofficio members like- Collector as vice president, Principal of the college as secretary, representatives of M.L.A. and M.P. of the area, two faculties from the college, two guardians, industrialist, representatives of S.T., S.C. and female categories. Chairperson of this samiti is nominated by the government. In this way, we can say that this samiti is based on PPP model of Management.

**Admission process** - College appreciates and practices decentralization and participative management for overall development of students and the institutions. Admission committee is one of the important

committees which ensure this practice. A team of three or two members is formed in which one is coordinator and other two work as members of the committee. Such committees are formed for all the classes. As soon as the last date of applications ends, these committees start their work. Admission forms and document verification are done by this committee and fee submission and rest of the admission process is done by the students section. In this way college decentralizes all the important activities.

Besides these committees several other units like **Women Cell, Science Club, Redcross and NSS unit** are functioning to participate in the smooth functioning and management of college.

#### 6.3.5 Institutions Performance Appraisal System for teaching and non-teaching staff

### **Response:**

The performance based appraisal system (PBAS) is strictly followed by majority of institutions throughout the nation and our institute is no exception. The institution takes into account the topologies of the PBAS system and implements its process to determine and evaluate the quality of the academics being carried out in the institute.

Performance Appraisal of teaching and non-teaching staff system is developed as per the guidelines of UGC with minor amendments done by the department of higher education government of Chhattisgarh. Gopaniya Prativedan(CR) is filled by the teaching staff based on the work done during the session along with the other academic activities such as participation in conferences, seminars workshops, guidance in research work, paper publication along with responsibilities of administrative academic and other nature shouldered during the session. This API based Performa is analyzed by the Principal and accordingly grading (GOOD, VERY GOOD, EXCELLENT AND ORDINARY) to faculties and non-teaching staff is marked. Duly marked CR FORMS are countersigned by the Additional Director of the higher education and secretary of higher education Govt. of Chhattisgarh. Scoring is countable for promotion purposes. A separate Proforma is available for class three and four employees based on physical capacity and decision making skills etc. This is filled and remarked by the head of the department and finally signed by the Principal. Whenever required, counseling is provided to staff to help them improve their professional capabilities.

Following are some of the features of performance appraisal of the faculties:

- Participation in training, orientation and faculty development programs.
- Progress in academics like Ph. D and NET-SET qualifications
- Execution of minor and major research projects.
- Presentation of research papers in national and international conferences.

### 6.4 Financial Management and Resource Mobilization

#### 6.4.1 Institution conducts internal and external financial audits regularly

#### **Response:**

During the formation of various committees at the beginning of the session, Principal, Govt. M.M.R. PG. College Champa forms a committee for the regular audits of various accounts, cash books etc. These internal audits are carried every month on periodical basis. The funds received from the UGC and RUSA are audited from the local CA firm. Fund generated by Janbhagidari scheme is also audited by the CA at the end of every financial year. The college conducts internal and external financial audits regularly. It has a well-framed accounting and auditing system evolved over the years of experience. The accounts are maintained by the Accounts Section. Account section maintains receipts and payments, Cash Books, Ledger Books, Cheque Issue Register, DFC (Daily Fees Collection), Voucher and Bills. The government fees account, non government fees account along with the self-finance, Janbhagidari accounts are audited as per the government rules and by a chartered accountant. For UGC and RUSA grants the same procedure is being followed. The college has successfully submitted utilization certificates of all the UGC and RUSA schemes. Accounts department of the college calculates arrears, income tax and deposit it in a stipulated time. Once in five years the Accountant General (AG) office, Chhattisgarh, audits all the government accounts maintained by the college. This financial audit process is very important because any financial discrepancy observed in audit is taken very seriously and affects the pension fixation procedure of the head of the institution. Thus extra efforts are put by the Principal on the account persons to keep cash books of every head ready and correct. However, utilization fund received from government department is audited by C.G.A.G. Raipur and Department of Higher Education as well.

#### 6.4.3 Institutional strategies for mobilisation of funds and the optimal utilisation of resources

#### **Response:**

The college is affiliated by Atal Bihari Vajpayee University, Bilaspur and included under section 2(f) section 12B of the UGC Act, 1956. It is fully eligible to receive the grants under various schemes of UGC. The institution gets funds from the state government, UGC, RUSA and state govt. etc. The salaries and other benefits of the employees are provided by the state government. Government purchase rules are followed to monitor effective and efficient use of available financial resources, Budget provision is made by the state government. Similarly, UGC and other funds are managed as per the directions and norms of concerning agencies. For the resources generated through self-financing courses, tender process is followed whenever required. The major heads of the source of funds in Govt. M.M.R.PG. College, Champa is mentioned below:

**RUSA**: In the year 2013-14 a new scheme RUSA "Rashtriya Uchchatar Shiksha Abhiyan) has been launched by Govt.of India to enhance the quality of higher education. The funds under the RUSA scheme have been utilized for the development of good infrastructure and technological upgradation in the college.

**UGC grant:** College has received many grants from the UGC as per the proposals sent by the UGC in charge of the college. During this period college has received infrastructure grant, book purchasing grant and development grant.

**Amalgamated fund**: Fees collected from the students as amalgamated fund is utilized in various student centric activities like sports activities, annual gathering, magazines and periodicals in library, etc.

**Salary component:** The government pays the salary of the faculties. Govt. of Chhattisgarh also gives an order every year to appoint the teachers against vacant posts at the beginning of the session with fixed wages as Guest Assistant Professor. In the self-financed courses, faculty and the staff are paid from fee collected from students of that course. Approximately 60% of the fee collected is spent on the salary of faculties and staff appointed through Janbhagidari Samiti.

**Students' Scholarship:** The College caters to the reserved category and financially weaker sections of students in terms of scholarships. State government provides these scholarships. The college takes care that these students get the scholarship on time.

**Award to students:** Cash prize to the students with extra ordinary performance topper students is given through fixed deposits made by the Philanthropists and Professors of the college which is mentioned in the best practices under the title "Inspire the achievers". This is given as an appreciation for their academic achievements.

**NSS Unit:** Atal Bihari Bajpai University (parent University) gives a grant to one unit of NSS operational in the college. It is utilized for various social activities especially in adopted villages during seven days camp.

### **6.5 Internal Quality Assurance System**

# 6.5.1 Internal Quality Assurance Cell (IQAC) has contributed significantly for institutionalizing the quality assurance strategies and processes

#### **Response:**

For quality confirmation, quality enhancement, appraisal and accreditation, and regulation, the college has built up an Internal Quality Assurance Cell on 28th July 2014. From that point forward, IQAC has achieved instrumental grip in recommending various quality improvement gauges in the college.

#### IQAC initiatives are as under:

#### 1. A glimpse of ICT teaching-learning capabilities:

To counter the ever-growing world scenario, IQAC has tried to keep pace with the ICT enabled teaching-learning process. As a result of this, IQAC initiated to set up three ICT enabled **SMART CLASSROOMS** laying out a strong foundation for smart study environments. 45 computers and 5 LCD Projectors for facilitating the teaching-learning process are available in the college. E-journals, power- point and slide-based teaching, interactive sessions, N-List membership, e-books database, strong and robust internet connection with on- campus Wi-Fi facility are available for the students and staff. Most of the teachers at the college are having their social-media connections and YouTube Channels for circulating study materials and clearing the ambiguities of students. Several audio-video lectures are made available as per the individual capacities of the teachers.

N-List membership process was initiated on 11-02-2020, but delayed due to Covid-19 situation. Finally the institution got registration on 01-04-2021.

#### 1. Integrating and enhancing the research atmosphere in the college:

IQAC plays an important role in inculcating research culture in the college. The college has communicated a proposal for research center of Ph. D. research program. 01 faculty member is recognized research supervisor in commerce and 02 research scholars have completed Ph. D under his esteemed guidance in total. Faculties of the college have published 04 research papers in the journals notified by UGC. A good number of papers have been presented in conferences/workshops/symposiums.

- 1. Participation of students in numerous events like general awareness podiums, environmental and science-based quiz events, project making events and various field works
- 2. The college has established a well-nourished and efficiently equipped Smart Class rooms with epodiums and woofers from RUSA funding.
- 3. Suggestion are provided to the faculties for presenting their research works in reputed National/International conferences and seminars through UGC and other funding agencies.

#### **Response:**

The college effectively monitors and reviews its process of teaching-learning, structures & methodologies of operations and learning outcomes at periodic intervals through IQAC.

Following are two examples of institutional reviews and implementation of teaching- learning reforms facilitated by IQAC

#### Student's Feedback

Feedback is an essential part of the teaching-learning process. The analysis of the effectiveness of teaching-learning is made precise through the mechanism of stakeholder's feedback. It helps the mentor in recognizing that how the students know his or her subject being taught and the methods to enhance it continuously. The collection and analysis of feedback from different stakeholders assist the institution to understand the need of society.

Keeping this view in the centre, IQAC has developed a systematic and well-structured feedback system. IQAC prepares various feedback forms and collects structured feedback on design and review of syllabus

and student feedback on teachers. Each department analyses the feedback, discusses in the departmental meetings and submits a consolidated report to IQAC. IQAC prepares an inclusive feedback report of the college and communicates to concern meetings of HODs of the college for further improvement and implementation. Students learning outcomes are reviewed through class tests, assignments, class seminars, field projects, internal assessment tests, and university examinations. University result analysis is made for each class/semester at the departmental level and is discussed in IQAC/College meetings.

#### Strengthening of ICT Infrastructure and its use

Institution has well established mechanism for upgrading and deploying information technology. College has total 45 computers out of which 35 computers are in computer lab. 15 computers were purchased in the year 2019-20 from RUSA fund which are still not installed because of Covid-19 situation. College has been under taken by the local administration as Covid hospital since May 2019-20. At present College has four Wi-Fi connections. One of these connections is under BSNL service providers and is named Wi-Fi Choupal, a free scheme of Bharat Sanchar Nigam Limited for the educational institutions. College has three smart classrooms which were established in the year 2019-20 and are under the premises of Covid-19 wellness center at present.

Dry waste mainly leaf litter is allowed to decompose systematically over a period in the waste management pit. There is sanitary napkin vending and destroyer machine installed in the girls toilet for the proper waste management of sanitary wastes. Plastic Bags are banned inside the campus.

# 5. CONCLUSION

#### **Additional Information:**

Faculties of the college are highly qualified and experienced. Many of them are appointed as chairperson and Dean in the current affiliating University, Shaheed Nandkumar Patel Vishawavidyalaya, Raigarh. Few of them have the honor of being key-note speakers and resource persons in various conferences and seminars. The college conducts different competitive examinations organized by the Govt. of Chhattisgarh like Vyapam, PAT, PET and many others. College administration has taken extra efforts during pandemic period and facilitated sanitizer, masks, face- shields etc. to the staff members and installed sanitizer stands inside the buildings. With the efforts of Alumni Committee the Alumni association has recently got registered with the firms and society. Likewise N-List subscription could be made possible after the assessment period. Proposal of two new value aided courses is communicated to the Higher Education Department for Communication Skills and Basic Applications of computers. The college has also communicated with the govt. authorities to install solar system inside the college to save energy.

The College administration has faced several critical challenges while preparing the SSR. Many important parts of infrastructure of the college has been under the possession of district administration, since April 2020, till date. Library building, fourteen classrooms including three smart classrooms, girls common room, staff room, conference hall, playground, rainwater harvesting pit, waste management pit, under construction indoor hall, cultural events stage, fee counter, main entrance gate etc. were under the possession of **COVID-19 WELLNESS CENTER**. Recently in the session 2021-22, the college has occupied library building and few portion of the campus as minimum required infrastructure. Because of limited infrastructure availability, geotagged photographs and other amenities of the college has not been properly projected in the SSR.

## **Concluding Remarks:**

Our College is best and renounced in the field of providing co-education for nearby students. College is known for its well knowledge and gentle academicians. Providing knowledge under disciplined, education friendly cool and calm environment, the college leads towards maximum girl's enrollment. During last five years the girl's enrollment has regularly showed uptrend. Every year more than 50% of total enrollment is of girl students. Parents of these girls feel-free and fearless by getting there ward admitted in Govt. M. M. R. PG. College, Champa. To provide hassle-free atmosphere to all students and guardian a help-desk system is set hear to facilitate the newly coming students. College owned 10 acres of land in its possession and sufficient rooms and laboratories are available for the students. Two new building containing 14 rooms is newly built in the campus. Apart from these, a separate library building containing 26658 books is also available for students. ST/SC/OBC students utilize the provided Book Bank facility. Outdoor and indoor sports facility is also available for the students. Students of our college took part in sector level, district level, university level and national level sports events and have performed well. To spread speaking awareness and personality development a short term English Speaking certificate program was provided to the students. Students from all the disciplines were enrolled in this certificate program. N.S.S. and Red-Cross unit are also in function in the College. Many community and out-reach program were organized through these units. Annual camp and regular activities are carried out by N.S.S. unit. Many program of social importance like health check-up and blood donation are organized under Red-Cross unit. Special days, dates and functions were also organized to groom the student's personality. In this way the college has engaged itself in doing useful and necessary activities to develop able and competent students so that they may overcome the modern day's challenges.
